At its meeting on December 9, 2016, The Alabama Commission on Higher Education approved the following programs for the University of Alabama (UA):

- Doctor of Philosophy in Geography (CIP 45.0701) [Decision item E1]
- Juris Masters with Concentration in Taxation (CIP 22.0211) [Decision item E5]
- Master of Arts in Religion in Culture (CIP 38.0201) [Decision item E6]

The programs were approved with post-implementation conditions and the requirement of a post-implementation report.

At that meeting, The Alabama Commission on Higher Education approved the following extensions/alterations of existing programs/ units of instruction for the University of Alabama:

- Addition of a Concentration in Production to the Existing BACIS in Creative Media (CIP 09.0799) [Decision item F1]
- Addition of a Concentration in Sports Media to the Existing BACIS in News Media (CIP 09.0499)
   [Decision item F2]

Please note that, in accordance with Commission operating definitions, concentrations/tracks in academic programs are not identified separately in the Commission's Academic Program Inventory, and the institution may not identify them as degree programs.
