WHEREAS, the School of Social Work at The University of Alabama currently offers Bachelor's, Master's, and Doctor of Philosophy degrees in Social Work; and

WHEREAS, The School of Social Work prepares scholar-practitioners and researchers committed to ending adverse social conditions and promoting societal well-being through teaching, research, and service; and

WHEREAS, the School of Social Work seeks to support the professional development of highly skilled social workers to meet the need for professional social workers in leadership roles in clinical, policy, research, advocacy, and educational settings by offering comprehensive social work degree options; and

WHEREAS the need for advanced clinical social work practitioners is growing in many critical areas including mental health, behavioral health, and substance abuse; and

WHEREAS the Social Work (D.S.W.) Program will be supported by the expertise of the faculty in the areas of clinical social work, advanced policy practice, community engaged scholarship and program administration. Additionally, the D.S.W. Program will contribute to the University's mission to advance the intellectual and social condition of the people of the state, the nation and the world; and

- 6. Statement of Program Objectives (Objectives should be precise and stated in such a way that later evaluation/assessment of program outcomes is facilitated):

The Doctorate of Social Work (DSW) degree is an advanced clinical practice degree. Currently, there is a need for social workers with advanced clinical knowledge beyond that of a MSW (Master of Social Work) degree. Edward, Rittner and Holmes (2011) stated that "The advanced practice doctorate is an important recent development in community-based professional social work practice and this degree is expected to fill any number of growing needs in social service agencies, health and mental health care institutions, and community organizations". In Alabama, social workers interested in filling these needs must leave the state to obtain a DSW degree, or they are forced to use sporadic continuing education trainings to develop these skills. The DSW Degree Program at The University of Alabama will be designed to address these needs. The stated program objectives are as follows:

The University of Alabama Doctorate of Social Work (DSW) program prepares students for excellence in advanced clinical social work practice, community-engaged scholarship and social work education and leadership. Graduates of this program will:

- A. Demonstrate advanced clinical social work practice skills including specialized clinical assessments, psychosocial interventions and clinical supervision.
- B. Develop systematic analyses and collective action plans to address critical issues faced by vulnerable and underserved communities.
- C. Apply principles of social work organizational leadership, management and supervision.
- D. Develop and implement best practices in social work education and program administration.
- 7. Relationship of program to other programs within the institution.
  - a. How will the program support or be supported by other programs within the institution?

This program will be supported by The University of Alabama's School of Social Work. The School of Social Work currently offers Bachelor's, Master's and PhD degrees in Social Work. The School of Social Work faculty members have research and practice expertise that will support a DSW Program. Additionally, the School of Social Work has dedicated advisors and career services specialists who will support the students enrolled in the DSW Program. The School of Social work also has recruitment specialists who will be available to support prospective students considering enrollment in the DSW Program.

The DSW degree is not duplicative or competitive with the PhD in Social Work degree that is currently offered in the School of Social Work. The notable difference is that the PhD is "a research-oriented degree preparing graduates for advanced research and academic positions that are research intensive. A DSW degree includes practice-oriented research and evaluation that focuses on preparing students for innovative, complex, and sophisticated areas of practice, i.e., evidence-based practices in areas that focus on the health and mental health needs" (Carter & Hawkins, 2014). Given the vast differences in these degree programs, the prospective student profiles would also be very different and therefore the programs would not compete for students. The DSW would be a more viable option for experienced, licensed social workers who want additional expertise in clinical practice and community and agency-based research (Thyer, 2015).

8. If this program is duplicative of any other programs in the state, please give your rationale for program duplication.

There are no other DSW (Doctorate of Social Work) Programs in the State of Alabama.

9. Do you plan to explore possible program collaboration with other institutions? Please explain.

At this time, there is not a plan to collaborate with other institutions in the state since there are no other DSW programs. However, collaboration with other programs and institutions will be explored in the future in terms of recruitment efforts of graduates of the other MSW programs in the state.

10. Do you anticipate the use of distance education technology in the delivery of the program? Please explain.

Yes, this program will be designed as a distance education program. The format will use a hybrid model including on-line courses and face-to-face learning opportunities.

11. What methodology will you use to determine the level of student demand for this program?

We will examine the enrollment and graduation trends of MSW Programs in the southeast. We will also survey our MSW Program alumni and the membership of local, state and national professional social work organizations.

12. What methodology will you use to determine need for this program?

The need for social workers with advanced practice degrees will be ascertained by examining labor and employment trends in the areas that employ social work practitioners including but not limited to: mental health, behavioral health, and substance abuse agencies.

Additionally, we will examine the need for DSW graduates as potential faculty members. A recent study found that the majority of the social work education administrators that participated in the study would consider hiring a graduate of a DSW Program in a faculty position (Barsky, Green, Ayayo, 2014).
